Whether the places are enhancements of your daily reality or depictions of your dreams, let your imagination be your guide. Both exterior and interior “locations” are welcome.

## Schedule

**Friday, September 15**

Mailed application form and CD with images, or online submission, must be received by Bryan Memorial Gallery on or before this date.

**Friday, September 29**

Artists will be notified of the jurors’ final decision on what works will and will not be included in this exhibition, via either email or jury card if you submitted by mail.

**October 1 - 31**

All paintings for this show must be shipped or delivered to Bryan Gallery, PO Box 340, 180 Main St, Jeffersonville, VT 05464. Please note office hours: M – F, 10 – 4.

**Thursday, November 9**

Exhibit opens to the public

**Sunday, November 12**

Artists Roundtable at 1 PM: Reception: 2 – 4 PM

**Sunday, December 23:**

Last day of exhibition. OK to pick up artwork. Other days/hours for pickup will be announced.

**Eligibility:** All artists working in two and three dimensions are eligible to submit an application to this exhibition. If your work is accepted by the jury, you must be or become a member of Bryan Memorial Gallery to have your work exhibited in **Fantastical Landscapes**. A membership form can be found at [www.bryangallery.org/membership.php](http://www.bryangallery.org/membership.php). **All painting, photographs and sculpture must be available for sale, and must not have been exhibited in Lamoille County, Vermont, previously.**

**Medium:** Only original artwork and photographs, conceived and created by the entrant, will be considered. Sculpture, not to exceed 36” in any dimension will be considered also.

## How to enter:

You may submit up to 3 entries. There are two ways to enter. The preferred method is to use the online entry form which you can find here: <http://www.bryangallery.org/artistsadmin/> Follow the instructions on the entry page. The second method is to print the entry form, and send all information including a disc with images through the mail. Images of all entries must be uploaded as jpegs, or presented as jpegs on CD (if mailed). Mailed entries must be accompanied by an Official Entry Form or facsimile. Applications should include one jpg image for each of the specified number of entries, of the paintings you would be submitting for the exhibition itself. If mailing your entry, mail completed packet to **Bryan Memorial Gallery, PO Box 340, Jeffersonville, VT 05464**. Mailed entries should have the images sent on CD and completed entry form.

**Jury process:** The jury will review each artist's entries and select the artists to be included in the exhibition. The jury's decision will be conclusive. If submitting online you will be notified by email. If mailing your entry we will return your Jury Card via mail.

**Framing and/or installation:** Paintings and photographs must be suitably framed or painted edges of gallery wrapped canvas. Cable suitable for hanging must be on the backs of all 2 dimensional works, or there must be another suitable hanging method. Photos printed on metal are OK as long as there is a means provided to install them. For sculpture, please confirm that the Gallery has the appropriate means to install.

**Insurance:** Each artist understands and agrees that insurance by Bryan Gallery is not available for either jurying materials or artwork. All risks of loss or damage at the gallery or in transit will be borne by the artist.

**Digital images:** Images must be submitted in high resolution jpeg format on CD (no DVD's), with files less than 5 MB. *Images should be a minimum of 1200 pixels wide in landscape orientation or 1000 pixels tall if in portrait orientation.* If someone else is making your CD, please notify them how to name the files. If you want your CD returned, please provide a self-addressed, stamped envelope.

**Delivery to the Gallery:\*** Each artist whose work is juried into this exhibition will be notified as to which pieces to deliver to the gallery. Paintings must be received at the gallery on or before October 31, 2017. The artwork can be delivered in person or shipped to the gallery (at the artist's expense).

**Receipt Form:** The titles and prices listed on your submission to the jury must not be changed before the exhibit, so please title and price your work carefully on the application. No substitutions will be accepted.

**Tags:** Artists must attach TAGS to the back of the accepted works with their Name, Title of Work, Image Dimensions (Height x width: excluding mat and frame.), Medium and Price.

**TAGS are available at the gallery's website at [www.bryangallery.org/calltoartists.php](http://www.bryangallery.org/calltoartists.php). Please have your work labeled in advance of bringing it into the gallery.**

**Sales and Commissions:** If your work is juried into this exhibition and is sold during the exhibition, the Gallery's commission will be 50% of the retail price you have designated or later approved before sale.

**Exhibition dates:** Accepted artists must agree to leave their paintings at Bryan Memorial Gallery for the duration of the exhibition. No exceptions.

**Returning unsold paintings at exhibit's end:** After the exhibition, any unsold paintings will be returned to you. You may pick them up in person at the gallery, or the gallery will ship the paintings back to you at your own expense, in the packing materials you have provided. Please note the dates for pick up as the gallery has very little storage space.
