**Subject: Vermont, New England and Northeastern landscape paintings**

### Schedule

<b>Friday, July 14:</b>	Submissions including images, fee and documentation – must be received by Bryan Memorial Gallery on or before this date.
<b>Thursday, Aug 4:</b>	Artists will be notified of the jurors' final decision on what works will and will not be included in this exhibition.
<b>August 5 – August 28:</b>	All paintings for this show must be shipped or delivered to Bryan Gallery, PO Box 340, 180 Main St, Jeffersonville, VT 05464
<b>Friday, September 8:</b>	Exhibit opens to the public
<b>Sunday, September 10:</b>	Reception and awarding of prizes 2 – 4 PM
<b>Sunday, November 5:</b>	Last day of exhibition. OK to pick up of artwork.

**Eligibility:** All artists painting in two dimensions are eligible to submit an application to this exhibition. If your work is accepted by the jury, you must be or become a member of Bryan Memorial Gallery to have your work exhibited in **LAND AND LIGHT AND WATER AND AIR**. If you have been a recent member of Bryan Memorial Gallery, but your membership is not current, a Membership form can be found on the gallery's website: <http://www.bryangallery.org/membership.php>. **All paintings must be available for sale, and must not have been exhibited in Lamoille County, Vermont, previously.**

**Medium:** Only original two-dimensional paintings, conceived and created by the entrant, will be considered. Photographs, sculpture, digital or computer-generated artwork will not be considered for this exhibition.

### How to enter:

You may submit up to 3 pieces to this show. There are two ways to enter. The preferred method is to use the online entry form here: <http://www.bryangallery.org/artistsadmin/> Follow the instructions on the entry page. The second method is to print the entry form, and send all information including a disc with images through the mail.

Images of all entries must be uploaded as jpegs, or presented as jpegs on CD (if mailed). Mailed entries must be accompanied by an Official Entry Form or facsimile. Applications should include one jpg image for each of the specified number of entries, of the paintings you would be submitting for the exhibition itself. If mailing your entry, mail completed packet to **Bryan Memorial Gallery, PO Box 340, Jeffersonville, VT 05464**. Mailed entries should have the images sent on CD and completed entry form.

**Fee:** \$25 check to Bryan Memorial Gallery to cover the non-refundable application fee to be considered for this exhibition. If paying online, go to Call To Artists and look under FEES.

**Jury process:** The jury will review each artist's entries and select the artists to be included in the **2017 Land and Light and Water and Air** exhibition. The jury's decision will be conclusive. The prizes will be juried from the actual paintings. If submitting online you will be notified by email. If mailing your entry we will return your Jury Card via mail.

**Insurance:** Each artist understands and agrees that insurance by Bryan Gallery is not available for either jurying materials or artwork. All risks of loss or damage at the gallery or in transit will be borne by the artist.

**Submitting Your Images:** Professional looking images must be submitted in high resolution jpeg format under 5 MG. These images will be used for the Gallery's website and public relations. There are two ways to submit your images. On line by going to <http://www.bryangallery.org/artistsadmin/> or by sending your images and info by mail following these directions: Image files must be titled as follows: **Last Name of Artist Title of Work, i.e. "Picasso Mt. Mansfield."** Please do not use punctuation marks (such as, # \$ % ^ & \*()+="';, / {}|:<>?~) in the filename. If someone besides you is doing your photography work for you, please notify them of how to name your files. If someone else is making your CD, please notify them how to name the files. If you want your CD returned, please provide a self-addressed, stamped envelope. Images should be a minimum of 1200 pixels wide in landscape orientation or 1000 pixels tall if in portrait orientation.

**Delivery to the Gallery:\*** Each artist whose work is juried into this exhibition will be notified as to which pieces to deliver to the gallery. Paintings must be received at the gallery on or before August 28, 2017. The artwork can be delivered in person or shipped to the gallery (at the artist's expense.)

**Receipt Form:** The titles and prices listed on your submission to the jury must not be changed before the exhibit, so please title and price your work carefully on the application. No substitutions will be accepted.

**Tags:** Artists must attach TAGS to the back of the accepted works with their Name, Title of Work, Image Dimensions (Height x width: excluding mat and frame.), Medium and Price. TAGS are available at the gallery's website, [www.bryangallery.org](http://www.bryangallery.org). Click on "Call To Artists" under "Artists".  
**Please have your work labeled in advance of bringing it into the gallery.**

**Sales and Commissions:** If your work is juried into this exhibition and is sold during the exhibition, the Gallery's commission will be 50% of the retail price you have designated or later approved before sale.

**Exhibition dates:** Accepted artists must agree to leave their paintings at Bryan Memorial Gallery for the duration of the exhibition. No exceptions.

**Returning unsold paintings at exhibit's end:** After the exhibition, any unsold paintings will be returned to you. You may pick them up in person at the gallery, or the gallery will ship the paintings back to you at your own expense, in the packing materials you have provided. Please note the dates for pick up as the gallery has very little storage space.
